ELIGIBILITY

Should the trip be oversubscribed, the trip organiser will select participants at random and create a waiting list. It is important that you pay your deposit by the deadline given – late payments will not be accepted. Any unpaid deposits will result in your child losing their place, and the next student on the waiting list will be offered the place.

FINANCIAL PROTECTION

Interski operate using Trust Accounts. This means that all money paid to Interski is held by their fully Independent Trustees until you arrive back from the trip. This method of protecting consumer monies is one of the most robust available and is fully compliant with the Package Travel and Linked Travel Arrangements Regulations.

PAYMENT INSTALLMENT PLAN

Please see below the instalments broken down for the trip. Payments and consent can be made via the school's online payment platform IRIS.

Please note by giving consent and payment via IRIS, you are also giving consent for your child to have "free time" with remote supervision in the accommodation if applicable.

Please note that students entitled to the Pupil Premium can use this allowance to pay for part of the trip excluding the deposit (subject to sufficient funds remaining).

PASSPORT AND DOCUMENTATION

At the time of travel, students must have a valid UK passport with more than six months remaining on their passports. This is subject to change depending on Government guidelines. All students will require a UK GHIC/EHIC card to travel. Holders of British

passports do not need a visa to enter Italy. If your child does not hold a British passport, we advise you check the entry requirements for Italy with your embassy.

CANCELLATIONS AND REFUNDS

In the event that you are unable to go on the trip, we will endeavour to recover, from the tour company, what is allowable under the conditions (see below).

"If you or any member of your party, decides to cancel your confirmed booking you must notify us in writing. Your notice of cancellation will only take effect when it is received in writing by us and acknowledged and will be effected from the date on which we receive it".
